RESOLUTION ORDERING A SPECIAL ELECTION TO BE HELD NOVEMBER 3, 2009 FOR THE PURPOSE OF ELECTING THREE MEMBERS OF THE BOARD OF TRUSTEES OF THE DALLAS INDEPENDENT SCHOOL DISTRICT TO DISTRICTS 1, 3, AND 9 FOR THE UNEXPIRED TWO AND ONE-HALF YEAR TERMS

BE IT RESOLVED AND ORDERED BY THE DALLAS INDEPENDENT SCHOOL DISTRICT:

Section I: A Special Election to be held in Dallas County on November 3, 2009, between the hours of 7 a.m. and 7 p.m., for the purpose of electing three members of the Board of Trustees of the Dallas Independent School District to Districts 1, 3 and 9 for the unexpired two and one-half year terms.

Upon election, the members shall qualify by taking the required Oath of Office.

Section II: In accordance with Section 2.021 of the Texas Election Code, if no candidate receives a majority of the votes cast for that position, **a run-off election is authorized and is hereby scheduled for December 8, 2009, if necessary.** At that run-off election, the names of the two persons receiving the highest number of votes for that position in the first election shall be placed on the ballot.

Section III: Early voting for the elections shall be conducted at the Dallas Independent School District, School Administration Building, 3700 Ross Avenue, Dallas, Texas, and at the following times:

Early voting by personal appearance shall be conducted as follows:

Section IV: The Director of Board Services is authorized and directed on behalf of the school district to coordinate the elections with the Dallas County Elections Department. Said Director of Board Services is generally authorized, empowered and directed to do each, every and all things necessary or desirable to carry out on behalf of this Board and the Dallas Independent School District the terms and provisions of this resolution and to conduct the general election so ordered in the manner and mode provided by law to the end that the judgment and decision of the electoral may be fairly and accurately ascertained.

Section V: Consistent with the Texas Election Code, all presiding judges and alternate judges, to be named by the Dallas County Elections Department, will be qualified voters of the election precinct in which they are named to serve. Clerks appointed to serve must be qualified voters in the Dallas Independent School District. No person shall serve as a judge or clerk who is employed by a candidate, or who is related within the second degree either by affinity or consanguinity to any candidate whose name appears on the ballot in this election. No person who holds an elective public office such shall serve as a judge or clerk.

Section VI: Notices of the Election shall be posted at the School Administrative Building, 3700 Ross Avenue, Dallas, Texas, and a like-copy shall be published between the 30th day and the 10th day prior to the date fixed for the holding of said elections in a newspaper of general circulation.

Section VII: Consistent with Chapter 43 of the Texas Election Code, voting locations will be situated in each precinct and will be determined by the Dallas County Elections Department.

Section VIII: This special election and necessary subsequent run-off elections shall be held by the presiding judges (or alternate judges) and by the clerks appointed by the Dallas County Elections Department in the manner prescribed by law, and the holding of said elections and the making of returns, and declaring of results thereof, shall be governed by the general laws of the State of Texas. All pertinent provisions of the Texas Election Code, as amended through the acts of the Legislature, shall govern, and the purpose of the Board in the adoption of this Resolution is to fully and strictly comply with all of the terms and provisions of said law and statutes.

Section IX: Immediately after said elections have been held, the officers holding the same shall make return of the results thereof, to the Director of Board Services of the Dallas Independent School District at the School Administration Building at 3700 Ross Avenue, Dallas, Texas, and thereafter the Board of Trustees will canvass the votes and declare the results thereof as provided by law.

RESOLUCIÓN PARA LLEVAR A CABO UNA ELECCIÓN EL 3 DE NOVIEMBRE DEL 2009, CON EL PROPÓSITO DE ELEGIR TRES MIEMBROS DE LA JUNTA ESCOLAR DEL DISTRITO ESCOLAR INDEPENDIENTE DE DALLAS DE LOS DISTRITOS 1, 3, Y 9 PARA EL TÉRMINOS DE DOS AÑOS Y MEDIO QUE NO SE HA VENCIDO

POR DECRETO DEL DISTRITO ESCOLAR INDEPENDIENTE DE DALLAS:

Sección I: Que se lleve a cabo una elección especial en el condado de Dallas, el 3 de noviembre del 2009, entre las 7 a.m. y 7 p.m., con el propósito de elegir tres miembros de la Junta Escolar del Distrito Escolar Independiente de Dallas de los distritos 1, 3 y 9 para el término de dos años y medio que no se ha vencido

Una vez elegidos, los miembros deberán reunir los requisitos tomando el juramento requerido.

Sección II: Según la sección 2.021 del Código Electoral de Texas, si ningún candidato recibe una mayoría de votos emitidos para ese puesto, se autoriza una segunda votación, y por este medio es programada para el **8 de diciembre del 2009, si es necesario**. En dicha elección, los nombres de dos personas recibiendo el número de votos más alto para ese puesto en la primera elección, deberán ser anotados en la boleta electoral.

Sección III: La votación anticipada para las elecciones debe llevarse a cabo en el edificio de la administración escolar del Distrito Escolar Independiente de Dallas ubicado en el 3700 Ross Avenue, Dallas, Texas, en los siguientes horarios:

Sección IV: El director de la Junta Escolar está autorizado para que en representación del distrito escolar, coordine las elecciones con el Departamento Electoral del Condado de Dallas. Dicho director de la Junta Escolar está generalmente autorizado para llevar a cabo los términos y provisiones de esta resolución y cualquier diligencia necesaria en representación de esta Junta Escolar y del Distrito Escolar Independiente de Dallas, para conducir la elección general, por decreto en la manera y modo emitido por la ley para que el juicio y decisión electoral pueda ser justa y asertada.

Sección V: Conforme con el Código Electoral de Texas, todos los jueces presidiendo y jueces alternos, para ser nombrados por el Departamento Electoral de Condado de Dallas, serán votantes calificados para el recinto de elección en el cual han sido nombrados a fungir. Los secretarios nombrados a fungir, deben ser votantes calificados en el Distrito Escolar Independiente de Dallas. Ninguna persona deberá fungir como juez o secretario que sea empleado por un candidato, que tenga parentesco en segundo grado por afinidad o consanguinidad con cualquier candidato cuyo nombre se encuentre en la boleta electoral en esta elección. Ninguna persona que sea un oficial público elegido deberá fungir como juez o secretario.

Sección VI: Las notificaciones de la elección deberán publicarse en el edificio administrativo escolar en el 3700 Ross Avenue, Dallas, Texas, y se deberá publicar una copia entre el 30^{vo} día y el 10^{mo} día, antes de la fecha establecida para dichas elecciones, en un periódico de circulación general.

Sección VII: Conforme con el capítulo 43 del Código Electoral de Texas, los lugares para votar estarán situados en cada precinto y serán determinados por el Departamento Electoral del Condado de Dallas.

Sección VIII: Esta elección especial y elecciones subsecuentes necesarias, deberán llevarse a cabo por los jueces presidiendo (o jueces alternos) y por los secretarios nombrados por el Departamento Electoral del Condado de Dallas en la manera prescrita por la ley, y la función de dichas elecciones y el conteo de papeletas, y la declaración de los resultados de la misma, deberán ser determinados por las leyes generales del Estado de Texas. Todas las disposiciones del Código Electoral de Texas, como enmendado por medio de los actos de la legislatura, deben regir, y el propósito de la Junta en la adopción de la presente Resolución, es cumplir totalmente con todos los términos y disposiciones de la mencionada ley y estatutos.

Sección IX: Inmediatamente después que se hayan llevado a cabo las mencionadas elecciones, los oficiales participando en las mismas, deben entregar los resultados al director de Servicios de la Junta del Distrito Escolar Independiente de Dallas en el Edificio Administrativo Escolar en el 3700 Ross Avenue, Dallas, Texas y a partir de entonces la Junta Escolar escrutinará los votos y declarará los resultados de los mismos según la ley.
