



## **INFORMATION AND CRITERIA FOR DASA SCHOLARSHIPS**

The Dallas All Sports Association (DASA) Scholarship Program provides college scholarships in the amount of \$1,000 - \$4,000 to selected high school seniors or selected full-time college students that meet the following criteria:

### **Eligibility Criteria**

- U.S. citizen for at least one year at time of application
- Current college student or U.S. High School senior
- Enrollment in a full-time course of study at an accredited 2 or 4 year-college or university

### **Selection Criteria**

- GPA of 3.0 or better (4.0 scale). (2.0 will be considered under special circumstances)
- Financial Need
- Overcoming challenges (educational, health, family and financial)
- Activities/Leadership
- Work History
- Candidate Appraisal
- Sports Program Participation recommended but not required

### **Scholarship Awards**

- Award amount: \$1,000 - \$4,000
- Scholarship made payable directly to institution, one half of award each semester or one-third each trimester

### **Application Guidelines**

- Application period: November 1, 2015 through December 1, 2015
- Electronic applications available during application period on DASA web site [www.dallasallsports.com](http://www.dallasallsports.com)
- Electronic application submissions will be accepted if mailed or e-mailed within above dates.
- Applications received will be acknowledged by e-mail only.

### **Awards Approval, Notification and Distribution**

- Notification: only award recipients will be notified by e-mail or mail by December 15, 2015
- Scholarships given at an Awards Ceremony - Dallas Mavericks Game, Half time presentation, January 5, 2016

### **Scholarship Renewal Criteria**

- Scholarship recipients may re-apply for three additional years or until an undergraduate degree is earned whichever occurs first, on the basis of maintaining a cumulative grade point average (GPA) of 3.0 on a 4.0 scale and continued full-time enrollment. Previous recipients must provide transcripts showing completion of studies and grade points.

## Dallas All Sports Association Scholarship Application

Applicant must be in the graduating class of a High School or enrolled in college. The schools may be public, private, or parochial. The applicant must have a financial need and must have displayed qualities of leadership.

The applicant must attend an institution of continuing education to be eligible for this one-year scholarship grant.
