# \$ FAFSA/TAFSA Checklist \$

*The FAFSA is a federal financial aid form that you fill out online. It is used by colleges and universities to determine the amount of financial aid (grant money) students will receive to help pay for college. The TAFSA is the Texas application for financial aid for DACAmented and undocumented students.*

**PART ONE: IF YOU HAVE A COMPUTER AT HOME and the STUDENT is a US Citizen or Permanent Resident:  
(If not, it's ok. Skip this step and bring the items in part two.)**

**Go to FSAID.ED.GOV to create an FSA ID for YOU and ONE parent. Afterward, write the usernames and passwords below.**
