What strengths do you see in your 11th grade data? What opportunities for growth do you notice?

- Class of 2023 is well positioned for degree completion if students continue to be successful in their college classes.
- There are 57 juniors with one student still needing to retake and pass TSI Writing. Advising Report shows CL for TSI Writing.
- All juniors are, or will be, enrolled in college Math during the Fall and Spring semesters, using the COVID TSI waiver.
- After Spring SAT School Day test, exemption forms will be submitted or students scoring 530 or higher on Math.
- Remaining juniors will take TSIA2 Math.
- 12 juniors are being closely monitored due to either low GPA or low credits earned.
- Juniors can earn up to 27 college credits if all courses are completed successfully.
- College grades are monitored every 3 weeks.

What strengths do you see in your 12th grade data? What opportunities for growth do you notice?

- All 60 seniors are positioned to graduate with their associate's degree if they continue to be successful in their remaining college classes.
- 4 seniors still need to retake and pass TSIA2 Math. They have previously taken college Math and failed.
- There are multiple discrepancies between CCR reports for TSIA Math and Writing. See advising reports.
- College grades are monitored every 3 weeks.

ACTION PLAN TO ADDRESS CREDIT HOUR COMPLETION

Objective	Strategy/Intervention	Indicator(s) for Success
On Track College Credits Earned	Counselors verify each student is enrolling in two morning college classes each semester	Successful completion of all enrolled college courses (students progress towards degree plan).
On Track College Credits Earned	Counselors track student's progress each semester using the Individual Progress Tracking Form to ensure they are completing the required hours in the appropriate degree plan sections.	Students progress towards degree plan completion.
On Track College Credits Earned	Students at risk of program removal are placed on an individualized Program of Study. Student loses privilege of selecting order of classes and college courses are mutually agreed upon between student and counselor.	Students progress towards degree plan completion.
On Track College Credits Earned	Students are encouraged, but not required, to enroll in S1 or S2. This creates a buffer for students if they fail a Fall or Spring college class.	Students progress towards degree plan completion.
On Track College Credits Earned	Seniors are allowed to enroll in Winter term or May term.	Students progress towards degree plan completion.

ACTION PLAN TO ADDRESS GPA'S BELOW 2.0



Objective	Strategy/Intervention	Indicator(s) for Success
Student Academic Standing – GOOD	Dallas College Success Coach scheduled meetings with students with Academic Standing of PROB1 or SUSP.	Student Academic Standing returns to GOOD.
Student Academic Standing – GOOD	Counselors meet with parent and student to determine issue(s) and formulate plan for success.	Student Academic Standing returns to GOOD.
Student Academic Standing – GOOD	Principal meets with student remind them of consequences for continued failure (D or F) in college failures (elimination from program).	Student Academic Standing returns to GOOD.
Student Academic Standing – GOOD	Principal requests permission from Anna Mays and/or Laquesha Foster for students to re-enroll in a class previously failed when students enter SUSP status.	Student Academic Standing returns to GOOD.

TSIA2 Passing Standards Met	Monitor SAT/ACT scores and submit Exemption forms for students.	TSIA2 Met or Exempt
TSIA2 Passing Standards Met	All juniors are enrolled in SAT/ACT Prep course.	CCR Readiness Achievement and TSIA2 Exemption
TSIA2 Passing Standards Met	Incoming students are prepped for TSIA2 Reading and Writing during Summer Bridge.	TSIA2 Met
TSIA2 Passing Standards Met	Select 9 th grade students enrolled in Reading 2 during Fall semester and rested.	TSIA2 Met
TSIA2 Passing Standards Met	Select 9 th grade students enrolled in TSI Prep class in Spring semester. Resources used: EdReady, TPR Workbook	TSIA2 Met
TSIA2 Passing Standards Met	Algebra II students take TSIA2 Math at completion of course (Spring semester).	TSIA2 Met
